



Wholesale Application Terms and Conditions

We're glad you're interested in becoming a wholesaler or reseller of our tents from North Seat Tent Company. Below you will find our terms and conditions for opening a wholesale application with Larptents.com. In order to complete the application form and sign and date this document, stating that you agree to our terms and conditions. Additionally, listed below, is important information that you need to know before making your first purchase.

Opening Order and Minimums.

For a reseller account that will be drop shipping, there is no opening minimum.

For a wholesale account we require a minimum order amount of **\$500**.

How to Place an Order:

When you are granted a wholesale/resale account a coupon code will be applied to your account on www.larptents.com. This coupon will be tied to your email address of your account and will grant you the appropriate discount. You may then place an order through our website.

Retail Pricing Policy:

We have a strict pricing policy. Our tents are already as low priced as possible, and, therefore, we only allow a 10% discount below or above the MSRP price listed on www.larptents.com. Not following this pricing policy will be grounds for immediate cancellation of this agreement and your account. We believe in bringing high quality products at affordable prices and will not bend the rules in this regard.

Payment Methods:

All payments are processed via Paypal and all major credit cards are accepted therein. We do not process COD, and all tents must be paid for in full before they will leave our warehouse. If you are unable to pay by credit card, or would like to make very large orders, we can accept checks or Wire Transfer, but we will not ship an order until all funds for the order have been collected. We do not offer credit of any kind. However, Paypal does offer a 6 month credit payment plan. Please visit Paypals website for more information.

Shipping and Handling:

We ship all orders via Fedex. We cannot ship to a P.O. Box.

Drop Shipping:

We do offer a drop shipping service. Orders will come labeled with "North Sea Tent Company" and shipping department labeled on the product. We are unable to white label our tents for your company.

Production Time & Availability:

Our general production time on a tent is two weeks plus 5 business days for shipping. Rush orders are not possible. Because most tents are ordered with custom color combinations we are unable to carry large amounts in stock.

Returns:

There are no returns. All sales are 100% final, with the exception of manufacturer defects. If there are problems upon receipt of a tent we require the following:

1. Please take a well lit photograph of the image.
2. Please write a good description of the problem.
3. Email the description and the photograph to info@larping.org.

Any issues that are result of manufacturer defect we are happy to fix and replace.

Damaged Goods:

It is expected that you inspect the tents you receive immediately after receipt. All damages must be reported within 5 business days of receipt. No exceptions will be made under any circumstance.

Use of Pictures Text:

Any account in good standing with Larptents.com may use our pictures and text on their website in order to sell North Sea Tent Company Tents.
